

1. Updates

The house that Dargaville High School built

A collaboration between Kāinga Ora and Dargaville High School's year 13 trade programme students, under the supervision of retired registered builders and teachers, has produced the second of four homes contracted to be built or relocated this financial year.

This home was transported via truck from Dargaville to Kaikohe. Now the house is in place, a local build partner will complete the final onsite building works with an expected timeline for completion and occupation by June 2023.

Hobsonville Point affordable housing

Kāinga Ora is converting the remaining Axis affordable homes in Hobsonville Point to KiwiBuild after Universal Homes and Fletcher Living communicated their inability to deliver to the Axis price points due to the increasing construction costs. Axis price points were not changed this year whereas price uplifts were applied to KiwiBuild. The increased KiwiBuild price caps are a more viable framework to negotiate the feasibilities of the projects with no guarantee of the full uplift in price. The change allows us to maintain housing construction momentum despite the market conditions and will mean Hobsonville Point still achieves the 20 per cent affordable homes target. Hobsonville Point is delivering 864 affordable homes in total. Universal Homes and Fletcher Living are to deliver 69 homes and a further four homes are yet to be contracted and therefore 73 homes to be delivered as KiwiBuild.

139 Greys Avenue Beacon Case Study

The Kāinga Ora 139 Greys Avenue team, Icon and Amotai are very excited to have been accepted for a case study which is now live. The case study highlights the social procurement targets which Kāinga Ora put into the main build contract for 139 Greys Avenue and focuses on Icon's learning while working to reach those targets with a specific focus on supplier diversity. MBIE's Beacon case studies highlight good practice in the construction sector. - This is the second Kāinga Ora Beacon Case Study following on from the Kāinga Ora Bader Ventura Passive House Project confirmed last year.

Winter Energy Study update

The Minister for Social Development and Employment is taking a paper to the Social Wellbeing Committee on 15 March 2023 to seek approval for the regulation changes needed to ensure that subsidies provided as part of the Winter Energy Study (the pilot) are excluded as income for the purposes of the Social Security Act 2018, the Public and Community Housing Management Act 1992, and the Student Allowance Regulations 1998.

This will ensure participating customers' income support payments are not negatively affected by the study. Timeframes are very tight to allow the study to start as early as possible in the winter months, and the regulations are expected to be in place by early May at the latest, preferably earlier.

From 13 March onwards, we expect eligible customers to begin receiving information packs on the Winter Energy Study. The packs are designed to provide full and transparent details on what the study involves and its core purpose of gathering data that might be used by Government and/or electricity retailers to help address winter energy hardship for low income New Zealanders in the future.

The information packs are co-branded Kāinga Ora/Mercury/GLOBUG, with the aim of recruiting customers into the study via verbal consent, which will be managed by the Kāinga Ora Customer Support Centre.

Due to the limited time available to recruit customers into the study ahead of winter, we have needed to distribute the information packs ahead of the regulations coming into effect. We have been clear in our customer communication that certain circumstances may result in the study being delayed or cancelled, and should the regulations be delayed, we will take the necessary steps to ensure customers are not unduly impacted.

Pending the regulations coming into effect, we are expecting the subsidies provided through the study to be provided between June – September this year, and for five months during the winter of 2024.

Community Engagement

Kāinga Ora attended the Newtown Festival on 5 March 2023 and received excellent feedback from the community we engaged with. This was an informal activity to share about the key projects happening in the area, answer questions, and provide information on our financial packages. We brought in some of our customers to support face painting and colouring in with community which was very popular.

We partnered with Porirua City Council, Statistics New Zealand, and Whanau Manaaki on the Porirua Census Party on 7 March 2023. The Census data is crucial for supporting better information regarding how many people are living in our homes and how we ensure what we are building is fit for purpose. We also had great discussions with the head of the Central Pacific Collective on collaborating on upcoming engagement activities.

We are meeting with Kāpiti Councillor, Sophie Handford, and Community Board member, Bede Laracy, this week to give them a tour of the Epuni Development in Lower Hutt and take them to the Remakery. This context was requested following a meeting with them a few weeks ago where they shared their work on Our Vision for Raumati and their hopes to work closely with Kāinga Ora on engagement with the community in alignment with this project.

We are meeting with Porirua City Council elected members on 9 March 2023 for a coffee to share an update on the Porirua Development Project, upcoming engagement, and to ask how we ensure they have the information they need to champion the project with their constituents. This will also enable us to tailor our official briefing to them on the Spatial Plan scheduled for 23 March to ensure we address any concerns in advance of that meeting.


Northland activities

The Northland Community Engagement and Partnership team has had a busy start to March 2023. Last weekend the team hosted a children's fun day event for Children's Day 2023. As well as providing activities for the children, information was distributed about Kāinga Ora and different financial products. The team spent time with couples and single parents, educating them about opportunities with the Kāinga Ora First Home Buyer scheme and grants.

Betsy Misiaga, Community Development Manager Northland, provided feedback on the importance of the event for families in the region: "Our engagement in these events are so crucial to community development. So many families out there are discouraged about the limited opportunities to buy their first home with the escalated cost of living. Hearing about our products gives them hope, joy and confidence about opportunities to purchase their own homes. Kāinga Ora needs to support them each step of the way".

On Saturday 4 March the team were privileged to host a stall at the Northland Pasifika Fusion festival. Members of the local community celebrated and showcased Pasifika culture with colourful Pacific attire and Pasifika food. Betsy described the event and the importance to Kāinga Ora: "It really meant a lot to engage in this community event because it's provided the perfect opportunity to support the Pasifika Community and promote our financial products. We had a lot of families stop by for a chat and ask about our First home buyer's grants and processes involved. We provided them with brochures that would help inform their families". There were a large number of families in attendance enquiring about building on whenua, which was then passed on to the financial team in Auckland.

Whanganui land purchase and storm water mitigations

To help meet the urgent need for more homes for families in Whanganui, Kāinga Ora – Homes and Communities has bought a 1.6 hectare vacant plot of land on 63 Kaikokopu Road. The site was purchased in August 2022 from local developer Lance Attrill. Our agreement was to acquire a single holding, and included a civil work contract for the former owner to subsequently create build-ready sections. Plans are still to be confirmed, but initial yield studies indicate we could potentially deliver 25 homes on the site, with spaces set aside for green areas and infrastructure requirements.

The cost was \$2million for the land, and the cost of the site and civil works is \$1.3million. We have a registered valuation that values up to 28 build ready sections at \$4.2million.

There have been concerns raised locally about the area being flood prone. Kāinga Ora identified and investigated this, and other development risks, during its due diligence investigations, along with the robust mitigations to manage these risks. The engineering design and earthworks detailed in Council's Resource Consents for land use and subdivision provide for a range of mitigation measures to manage this risk. The conditions of the consent confirm that the development meets Whanganui District Council's site engineering standards. A Land Use Consent for land use disturbance was also granted by Horizons Regional Council relating to site earthworks.

Currently civil and infrastructure work is being carried out by the developer and former owner of the land to make it build ready. We will be sharing with the community that we have purchased the site and will keep them updated on future plans, along with the measures in place to mitigate flood risks.


