

First new public housing in Auckland's Orākei since 2009

Kāinga Ora has completed 17 warm, dry new homes in Orākei Auckland and customers will begin moving in next week. This is the first Kāinga Ora delivery of new public housing in Orākei for nearly 13 years.

The 2,400sqm development on Grace Street comprises 3-storey walk-up apartments containing two and three-bedroom homes and a community room. It replaces three older properties. Shared amenities also include vegetable planters and a playground.

Grace Street is the first of two projects being delivered in Orākei during FX2022. The second is a 12home development in Sudeley Street, which is due for completion in June. Our build partner for both is Dominion Construction. Prior to these, our previous deliveries of new public housing in Orākei were Ngaio Street in 2009 and Kurahaupo Street in 1990.

Kāinga Ora and Accessible Properties Limited (APL) Memorandum of Understanding

Kāinga Ora and APL have developed a non-binding MoU to formalise their relationship, working arrangements and priorities. The Memorandum of Understanding sets out how the parties will work together to pursue options for bringing forward the development and delivery of public and affordable homes across the Western Bay of Plenty. HUD/Kāinga Ora will provide advice to you on options and any decisions required. Kainga Ora will work with APL on low key communications to mark the signing, with further planned once options and work has progressed.

Relocation of houses to Te Tai Tokerau

At the end of this month three homes from a redevelopment site in Auckland will be relocated to papakāinga land at Pouto Point south of Dargaville. These homes will be used to house three families from Te Uri O Hau, a Northland hapu grouping of Ngāti Whātua. The delivery of these homes to Pouto , art or velopme Point builds on earlier house relocations to the north and is part of the wider Kainga Ora relocatables programme which is repurposing homes from Auckland development sites to regional locations.
