### **Product Cost Fluctuations**

Information has been sent to build partners last week addressing product cost fluctuations and explaining the process Kāinga Ora is putting into place to enable partners to claim net increases on selected products from the cost used at tender.

COVID-19 related supply constraints and cost fluctuations are having an effect on the residential construction sector, which in turn is impacting Kāinga Ora and our partners. To date, we have been working closely with build partners to ensure access to materials and products wherever possible.

Since April 2020, build partners have been able to seek to claim for time delays and cost changes that are a direct impact of COVID-19 by using the claims process in our construction contracts. As a part of this, as well as other ongoing support for our build partners, Kāinga Ora is now finalising the process to enable build partners to claim any net increase in the cost of a material (from a list of stipulated products) from the cost used at tender

For current contracts, it will be linked to the COVID-19 clause to provide consistency regarding the direct impact of COVID-19. It will be subject to some considerations including the need for our partners to mitigate the impact of cost fluctuations, for example, by ordering in a timely way, and the maximum cost as listed under our National Supply Agreements.

We will contact our build partners next week to provide more details about the proposal for both current and future contracts.

### **First Home Partner**

First Home Partner went live at 9am on 5 October 2021. As of 4pm on Tuesday, 12 October 2021:

- One customer has been assessed as eligible for First Home Partner. This customer is based in the Auckland region.
- 54 customers have submitted applications that are currently under assessment, with 18
  of these currently being asked for more information as their submissions were not
  complete.
- 322 customers have begun the application process by at least creating a Kāinga Ora account in the First Home Partner Portal.

The next step for customers who are assessed as eligible for First Home Partner is for them to approach a participating bank for home loan pre-approval. Following that, the customer is required to identify and purchase an eligible new build home.
