

1. Updates

Boosting the supply of housing in Dunedin and Mosgiel

Kāinga Ora has recently finalised two significant purchases in Dunedin and Mosgiel.

We have purchased 11 new one-bedroom homes in Dey Street, Mosgiel, an have also secured a large Central Dunedin site in Stafford Street to provide more long-term warm and dry, homes for people in Otago.

Dunedin and Mosgiel are priority areas for new public housing in Otago based on demand, with 417 people on the housing register in the wider Dunedin area as at Jun 2023.

The Mosgiel homes are well suited to modern lifestyles and all come with their own allocated off-street parking. The 2,361m2 central Dunedin site that currently consists of a building and carparks will be leased as we start to plan for new homes to be built on the site.

Both of these acquisitions will go some way to helping meet the urgent need for more homes in the Otago region.

Public Service and Integrity Week 2023

Last week (7 - 11 August) was Public Service and Integrity Week at Kāinga Ora, where our people reflected on what it means to be a public servant and how we should conduct ourselves.

It was an internal comms-led campaign, with a theme each day, including conflicts of interest, transparency, sensitive expenditure and an interactive election quiz. All our people have been instructed to declare any conflicts of interest – both actual and perceived – complete six policy declarations, and complete a number of learning modules, including conflicts of interest, sensitive expenditure and risk management. Supplier briefing for Eastern Porirua civil construction panellists

Kāinga Ora UDD has hosted a market briefing for our civil construction contract r p n llists in Porirua on 18 August 2023. The briefing included all the relevant contractors from the Kāinga Ora National Civil Contractors Panel – with an emphasis on those local to Porirua.

This is part of our new way of delivering infrastructure and civils within Easte n Porirua (Te Rā Nui). As previously advised, we are moving away from using the Te Aranga Allia ce as the delivery model for future civils work in Te Rā Nui and will instead directly engage suppliers local to Porirua which have the capacity and ability to help us deliver on our stated b oader and social outcomes for the Eastern Porirua community.

Partnering with New Zealand Police to support our Te Mātāwai community

As part of our ongoing operationalisation of Te Mātāwai we have a rolling programme of key partners visiting the site to view the building and be briefed in detail on its management model. On 14 August 2023, the NZ Police Director of Partnerships, Tāmaki Mākaurau and Police personnel from the Auckland CBD were provided with a quided tour of Te Mātāwai.

Feedback from the tour was positive in relation to both the design of the building, and the provision of 24/7 onsite management and in-house support services in terms of reduced demand for Police assistance with any minor issu. The Te Mātāwai team will liaise with local Police representatives on a regular basis and there is a strong focus on working together to support the Te Mātāwai community to live safely and well



- 28 customers currently in TAS (in the past week we saw four households leave their temporary accommodations)
- 21 customers are living elsewhere
- 10 households are living in our own Emergency Response Ac ommodation

Central region

- 359 homes in the region have been assessed as having damage from the cyclone with the majority – 341 – considered minor damage
- We are aware of:
 - o Wairoa
 - two white placards
 - one yellow placard
 - o Hawke's Bay
 - seven while placards
- We have made 4,053 utb und welfare calls, and referred 312 customer to other agencies for support.
- There were 28 customers that were evacuated, but none required permanent rehousing.
