Building Momentum Webinar Series

On 10 May 2022 we aim to launch a quarterly webinar series as part of our Building Momentum programme. The intention is to share the insights, challenges, and progress of our most significant public housing projects and initiatives with the wider industry.

Episode One of the series will feature the Bader Ventura Passive House development in Māngere, with presentations from the project architect (Peddlethorp), builder (Precision Construction), and two Kāinga Ora representatives. The webinar will be recorded and circulated to attendees and, following the event, will be made available on the Kāinga Ora website.

Creating thriving communities through partnership in Counties Manukau

Keeping our customers safe and secure is a great foundation for creating thriving communities. This includes supporting and enabling our customers to help look after one another and be proactive in protecting their community.

The Māngere area office leveraged existing relationships with the local Neighbourhood Support Group to organise a meeting at the Bader Drive and McKenzie Road complex on Wednesday 6 April 2022. In attendance were Ross Donaldson, Senior Sergeant from the Māngere Police station. Michelle Hohepa, Area Coordinator for the Neighbourhood Support Group, and a number of Kāinga Ora staff from the Tāmaki Tai Tokerau Place Based group with detailed knowledge of the Bader McKenzie complex. Most importantly, there were five customers from the complex (one representing each building) who participated in the session, with a view to forming their own Neighbourhood Support Group for the complex.

Ross and Michelle gave great tips and advice to the group about keeping safe and secure, and what to prioritise when calling the 105 line or the emergency number 111.

There were discussions about regular community days, planned and unplanned Police patrolling of the complex, and a suggestion to start up a Youth Group to keep the young in the complex engaged and out of trouble.

Neighbourhood Support Group packs were distributed, there was plenty of kai, and a commitment was made to continue this collaboration with regular meetings.
