

Tauranga elder housing tranfer

Tauranga City Council and Khinga Ora agreed on a settlement date of 15 November 2022 for the purchase of around 200 tenants I social housing units in seven villages.

Good progress continues with the transition process, with Kāinga Ora meet and greets with tenants completed earlier this cont. It hants have also completed MSD consent forms agreeing to be assessed for Income Routed Rent, with these assessments to start later this month. Following completion of these, the ratio will receive their Kāinga Ora tenancy agreements at sign-up events in October. The countil has been installing heat pumps in all units and is on track for completion of Healthy Home, certilicates, and the Kāinga Ora maintenance team and maintenance partner have been undertaking walk-throughs of the units as part of the handover process. Ongoing proactive engage centrand communication by the Council and Kāinga Ora continues to ensure tenants understand and are comfortable with the steps of the transfer process.

Memorandum of Understanding signed to assist with masterplanning in Roskill LSP

Kāinga Ora and the Hay Family (a large scale land owner and landlord in Mt Roskill) have signed a Memorandum of Understanding (MoU) to work together to implement the redevelopment of the Wesley Town and Employment Centres. It was developed by our Legal Consultant Team at KPMG, and is non-binding and has no fiscal elements / risks for Kāinga Ora.

This MoU will help to advance the process associated with preparation of masterplans. Under the MoU the parties will explore any mutually beneficial outcomes and collaboration opportunities during the master planning process. Once the master plans are agreed, we anticipate they will form the basis

of a development agreement (or similar) between the parties that gives effect to the development anticipated by the master plans. The in principal master plan is expected to be complete around September 2022.
