

#### 1. Updates

#### 15-home Kaiapoi development completed

A 15-unit development on Dale Street and Williams Street in Kaiapoi has now been completed. This is the largest Kāinga Ora new state housing development in the area and replaces five older properties. The build partner was Miles Construction.

These new homes are one-and two-bedroom, single-level properties with many accessible features. There is a high demand for smaller properties in this region, where most current stock is three-bedroom. Tenants will be moving into these warm, dry new homes soon. Another development of five, one-and two-bedroom homes was previously delivered on Williams Street in November 2020.

#### First Retrofits delivered in Bay of Plenty

The first Kāinga Ora Retrofit properties in the Bay of Plenty have now been completed. Five houses (one each in Whakatāne and Ōpōtiki and three in Tauranga) have now been brought up to, or above, new build standards – adding another 50 years of life to the properties.

Alongside our build programme, which is delivering more homes at scale and pace, the Retrofit workstream is part of the wider Kāinga Ora programme to improve our older stock as around 40,000 homes will need upgrading over the next 20 years.

Improvements to make these Bay of Plenty homes warmer, drier and healthier included full insulation (walls, ceiling and floor), double glazing, improved airtightness, ventilation and new heating. New kitchens and bathrooms were added and the homes were converted to a more open plan living layout, making them more accessible.

A further 14 properties across the Bay of Plenty are expected to be completed in August 2021 under the Retrofit workstream.

#### Highbury Triangle reaches important milestone

A whakawātea (a cleansing) has recently been held at Highbury Triangle development in advance of civil works starting. About 10 Kāinga Ora staff members and iwi members attended the early morning blessing on 23 July 2021. The event was particularly significant because the Avondale development is currently one of our largest and most ambitious projects. The site, which is located within the North and West Auckland region, will include 236 homes.

As part of the whakawātea, the mauri (life force) represented by the whenua (land) was removed from below a mature pōhutukawa tree which is being retained as part of the development. The whenua will be returned to the same spot, and the mauri restored, when the apartment complex is complete.

Highbury Triangle development, which will target a 7 Homestar rating, will be made up of five apartment blocks of between six and eight levels. It will provide predominately public housing for our older customers and is being built to our Universal Design standards. Alongside this, there will be a component of market homes and commercial space.

As well as shared gardens and exercise areas, the development will contain a large community room with an open plan kitchen, an arts and crafts room and private meeting rooms. There will also be smaller community spaces within other apartment blocks. The development will be completed in stages from mid-2023 to mid-2024.
