### 1. Updates

#### Thirteen new homes for whānau in Richmond

Kāinga Ora customers are due to begin moving into 13 new public homes in Ric mond this month.

The new development on the corner of Gladstone Road and Waverley Street includes 12 twobedroom homes and one three-bedroom home. Kāinga Ora has taken over ownership of the homes after agreeing last year to purchase the homes upon completion.

A mixture of current customers and people on the public housing egister will move into the new homes.

Local iwi blessed the homes last week. Our Nelson, Marlborough and West Coast team also held an 'open home' for neighbours and stakeholders to look through the new homes, with about 50 people attending.

#### The Te Mātāwai model in action

The operating model for Te Mātāwai extends beyond our new buildings to cover our customers residing at lower Greys Avenue. Recently, one of our customers at Lower Greys Avenue found themselves in difficulty with an associate entering the complex and causing a serious nuisance. The customer in this case presented themselves to the Te Mātāwai reception and asked for help with managing their visitor. Te Mātāwai based teams wrapped around the customer, were able to calm the visitor and provided support to other Lower Greys residents. This was an early and good example of the operating model working in practise. It demonstrated the benefits of having on-site 24/7 support to address disruptive behaviour without the need for Police intervention.

#### Our customers and their whanau

- 217 customers have been rehoused to date
- 23 customers have vacated and left their Kāinga Ora prope ty
- 26 customers currently in TAS (in the past week we saw one household exit and one household enter)
- 16 customers are living elsewhere
- 9 households are living in our own Emergency Response Accommodation where in the past week we saw one household enter and two households exit the accommodation

### Central region

- 359 homes in the region have been assessed as having damage from the cyclone with the majority – 341 – considered min r damage.
- We are aware of:
  - o Wairoa
    - two white placards
    - one yellow placard
  - Hawke's Bay
    - seven white placards
- We have made 4,053 outbound welfare calls, and referred 312 customer to other agencies for support.
- There we e 28 customers that were evacuated, but none required permanent rehousing.
