#### 2. Updates

#### Ferncliffe Farm Business Case

- The Ferncliffe Farm Business Case is ready for joint Minister of Housing and Minister of Finance consultation.
- As the project is a significant track Kainga Ora Land Programme project, consultation with the Minister is required before the Business Case can be approved by the Kainga Ora Board.
- The Letter of Expectation receiled on the 18 March 2024 also states that the Ministers expect to be informed before the Kainga Ora Board makes any changes to existing investment in the Kainga O a Land Programme.
- Approval of the Ferncliffe Business Case is required by May 2024 to allow for earthworks construction to commen e in October 2024.
- Delays to Business Case approval will mean that commencing earthworks during the 2024/2025 earth orks season (Oct 24-Apr 25) could be delayed, and the project would be delayed for up to one year.
- his is all o subject to progression of a change to the underlying zone for Tauriko West which is being led by Tauranga City Council.
- The current programme allows for house construction to commence in late 2026 to align with the completion of the New Zealand Transport Authority, SH29 enabling works construction which was announced by Minister Brown and NZTA on date 13 March 2024.

#### 3. Matters that fall under Minister Potaka's Delegations

#### Winter Energy Study

- Kāinga Ora has partnered with Mercury Energy and GLOBUG to run the Winter Energy Study; a two year pilot programme focused on assessing if giving tenants certainty around electricity costs through a cap on their energy bill over the winter months encourages them to warm their home to healthy internal temperatures in the short term, and in the longer term reduces preventable government expenditure and improves the health and wellbeing of ur occupants.
- The project will provide robust evidence that could support the development o commercial electricity products and/or targeted government assistance.
- As part of the project establishment process, the previous Minister or Einance requested a year-one outcomes update, including financial expenditure against indemnity, would be prepared and made available to shareholding Ministers and the Minister of Energy as soon as is practicable.
- Kāinga Ora has now analysed interim results of year on of the Wint Energy Study (winter 2023) and an update can be provided to the Ministers on request
- The Winter Energy Study concludes in December 2024 when qualitative and quantitative analysis of winter 2024 is complete. A final report for the st\_dy will be available from May 2025.
